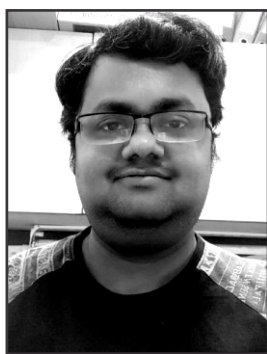

INFRASTRUCTURE AND FACILITIES

LIBRARY

Our library has a rich collection of 52,329 books covering an array of different disciplines. It subscribes 14 Hindi & English Newspapers, 55 magazines and journals at present.

E-Resources facility is also available through which students and teachers can access the world's best databases, DULS, E-Journals, E-books, N-List and Reports.

Our library is automated and ensures the availability of current titles by consulting publishers', catalogue, book reviews and publisher websites. Open access facilities to students and staff are available on the ground floor and upper library building. The College Library is air-conditioned.

The library is computerized with bar coded books and membership cards. The existing ceiling of the number of copies of a title to be purchased has been increased from five to twenty in view of new syllabi. The new arrivals are duly notified and prominently displayed.

The Computer lab with 36 computers is also available to students for searching the Delhi University Library resources and other resources through the internet facility.

COLLEGE NURSERY

From a humble beginning, college nursery fully blossomed with a large variety of foliage and flowering plant. College nursery participated for the first time in Delhi University Flower Show in 2008. In successive flower shows it won prizes in different categories making it possible with just one gardener.

At present nursery has variety of medicinal, ornamental, flowering plants like Xanadu, Oxycodium, Asparagus, China Rose, Yellow Jasmine, Ficus, Champa, Ashwagandha, Spider Plant, Basil, Papaya, Lemon Grass, Brahmi, Coleus, Dracaena etc. Garden committee remains active throughout the year and members regularly visit the college nursery.

A herbal corner has been planned for the nursery with the aim to sensitize the faculty and students about benefits of the herbal plants like Mentha, Stevia, Lemon grass, Peepli, Oregano etc. Covid Pandemic has been very heavy for many. Plants are great stress busters. In its upcoming activities College Garden Committee has decided to take greenery to the house of its stakeholders through online presentations.

W.U.S.

WUS is an International Non-Governmental Organization that focuses on education, development and human rights. It was founded in 1920 in Geneva under the title 'European Student Relief' which was renamed 'World University' in 1950. Today it has a network of national committees in more than 60 countries. The purpose of WUS is to work for the betterment of the society. It aims to spread awareness on a variety of health related issues. It focusses on the Physical as well as Psychological health concerns. WUS and Health Awareness Committee is focused on spreading consciousness about various health problems and their practices that can help in their treatment. Over the past so many years of its establishment, the society has conducted several workshops, seminars, camps and activities to realize its purpose and establish awareness among the students.

ICT INFRASTRUCTURE

ICT provides a means of effective content delivery in education. When used in conjunction with the traditional learning methods, they are quite complementary to each other, resulting in an enriched learning experience. In our college, ICT tools are being used by all the faculty to enhance the teaching-learning process. Furthermore, the college is always interested in new innovations and technologies. Various resources like Computer, Library, Internet etc. are available in the college for the faculty as well as the students.

Out of the courses taught in the college, ICT components are already included in all the pertinent disciplines. This includes the use of free/commercial software for practical classes and various other activities like assignments, presentations etc. Multimedia teaching aids like LCD projectors are usually used in the classroom. Moreover, LCD Projectors are also used during various seminars and workshops. Also, laptops are available for the faculty and students of the college under specific conditions.

Additionally, various departments organise seminars, workshops and guest lectures on the upcoming innovations and developments to aid effective teaching-learning by the faculty members and students. The college also has a Seminar Hall which is equipped with multimedia facilities and is used during such lectures and webinars.

The current pandemic has accelerated the process of adopting newer tools and techniques as mode of teaching has shifted from offline to online. The college has provided G Suite account to all the faculty of the college for the smoother conduction of online classes. Moreover, all the faculties of the college have also been provided Microsoft Teams account so as to ease task of conducting online classes with large number of students.

ENABLING UNIT

Enabling unit of the College has been catering to the needs of Visually impaired students as well as teachers from time to time. A special room with all the facilities has been provided to them in order to facilitate their academic work in the college. The College makes every effort to provide barrier free mobility to all PwD students everywhere in the campus. Ramps and signage on passages have been provided at maximum possible places. Where 100% barrier free mobility cannot be assured, classes for PwD students are conducted on ground floor to cause minimum inconvenience to them. From this academic year, two Lifts are also becoming functional. At the start of each session, during the orientation programme, the College organizes an interaction with the PwD students wherein the students are assured of all the required support from the College in enabling them to carry on all activities in and outside the class just like other students.

LIFT

For all students, teachers and especially PwD students, college has instituted and inaugurated two lifts inside the college building.

BANK

The College has a branch of the Central Bank of India with ATM facility in its premises which caters to all banking requirements of the staff and the students.

CANTEEN

The College has a spacious air-conditioned canteen providing quality refreshments and eatables at reasonable rates.

SPORTS GROUND

The College offers immense opportunities for students inclined towards sports, both indoors and outdoors. In addition to expert guidance, facilities exist for Cricket, Volleyball, Badminton, Handball, Football, Table Tennis, Hockey as well as for Athletics and Judo. The students of the college are actively encouraged to participate in these activities.

RESERVATION OF SEATS

RESERVATION OF SEATS FOR SCHEDULED CASTE(SC) AND SCHEDULED TRIBE(ST) APPLICANTS

- 22½% of the total numbers of seats is reserved for applicants belonging to Scheduled Caste and Scheduled Tribes (15% for Scheduled Caste and 7½% for Scheduled Tribes, interchangeable if necessary)
- It is a statutory obligation on the part of Colleges to fill all seats reserved for Scheduled Caste/Scheduled Tribe applicants.
- Colleges shall not refuse admission to any SC/ST applicant on the basis of medium of instruction. Any deficiency in the knowledge of any particular language should be addressed; for this purpose remedial classes may be arranged by the College by utilizing grants available from University Grants Commission.
- Relaxation to the extent of 5% in the minimum marks shall be given to the applicants belonging to SC and ST to determine their eligibility and merit for admission to the course concerned.
- In case, after giving 5% relaxation, the reserved seats still remain vacant, further relaxation would be given to the extent required in order to fill all the reserved seats. (AC Resolution A88, 14.6.1983) (EC Resolution 157.24.12.2001). It is obligatory for all Colleges /Departments to fill all the seats reserved for SC/ST applicants. Eligibility in these cases is pass percentage.

The following are empowered to issue the requisite SC/ST certificate:

- (a) District Magistrate/Additional District Magistrate/Collector/Deputy Commissioner / Addl. Deputy Commissioner / Deputy Collector / 1st class Stipendiary Magistrate/City Magistrate /Sub-Divisional Magistrate/Taluka Magistrate / Executive Magistrate / Extra Assistant Commissioner.
- (b) Chief Presidency Magistrate / Addl. Chief Magistrate / Presidency Magistrate.
- © Revenue Officer not below the rank of Tehsildar.
- (d) Sub-Divisional Officer of the area where the Applicant and / or his family normally resides.
- (e) Administrator /Secretary to the Administrator/Development Officer (Lakshadweep Islands)

The applicant must note that the SC/ST Certificate from any other person/authority shall not be accepted in any case. If the applicant happens to belong to SC or ST, applicant's caste/tribe must be listed in the appropriate Govt. of India Schedule.

The Caste Certificate should clearly state: (a) Name of his/her caste/tribe (b) whether applicant belongs to SC or ST (c) District and the State or Union Territory of applicant's usual place of residence and (d) the appropriate Govt. of India Schedule under which his /her caste/tribe is approved as SC and ST.

If the applicant does not have their SC or ST caste/tribe certificate at the time of registration/applying, they may upload the acknowledgment slip of the SC or ST caste/tribe certificate application. However, at the time of admission, the applicant will have to produce the valid original SC or ST caste/tribe certificate.

However, if an SC/ST Applicant seeks admission under some other category (for example : PwD/Employee Ward etc.) the applicant should satisfy the minimum eligibility requirement for that particular category.

Note : SC/ST applicants who get admission under open merit (unreserved) shall not be included in the reserved quota, i.e. 22.5% (15% for SC and 7.5% for ST)

It is obligatory for all Colleges /Departments to fill all the seats reserved for SC/ST applicants. Minimum Eligibility in these cases is pass percentage.

RESERVATION OF SEATS FOR OTHER BACKWARD CLASSES (OBC, NON-CREAMY LAYER, CENTRAL LIST)

- 27% seats will be reserved for the applicants belonging to Other Backward Classes (OBC) (noncreamy layer, central list).
- At the time of giving admission to an OBC applicant, the College will ensure that the caste is included in the Central List of OBC (the OBC status is to be determined on the basis of the Central (Govt. of India) List of OBCs notified by the Ministry of Social Justice and Empowerment on the recommendations of the National Commission for Backward Classes available at the website <http://ncbc.nic.in/backward-classes/index.html>). The issuing authority for OBC Non-Creamy Layer certificates is the same as for SC/ST.
- The certificate must mention non-creamy layer status of the applicant (Non-creamy layer status issued by an authority mentioned in DOPT Office Memorandum no. 36012/22/93-Estt. (SCT) dated 15.11.1993).
- The OBC applicants who belong to the 'Non-Creamy Layer' and whose caste appears in the Central List of the OBCs only, shall be eligible to be considered for admission under the OBC category (Validity period of OBC certificate in respect of 'non-creamy layer' status of the applicants as per DOPT Office Memorandum No. 36036/2013-Estt. (Res-I) dated 31march 2016). The validity of the non-creamy layer certificate shall be for the financial year 2019-20, issued after 31st March, 2020.
- If the applicant does not have the OBC non-creamy layer certificate of the latest financial year (2019-20) at the time of registration, the applicant may upload the previously issued (older) OBC non-creamy layer certificate or the acknowledgement slip of OBC non-creamy layer certificate application. However, at the time of admission, the applicant must produce the recent financial year's (2019-20) OBC non-creamy layer certificate, issued by the same competent authority. This additional certificate must have reference of the applicant's already issued original caste certificate.
- The OBC applicants shall be given a relaxation of 10% in the minimum eligibility marks of the said course and for the admission entrance test a relaxation of 10% of the minimum eligibility marks prescribed for General / UR Category applicants.
- It is a statutory obligation on the part of Colleges to fill all the seats reserved for OBC applicants.

RESERVATION POLICY FOR ECONOMICALLY WEAKER SECTIONS (EWS)

As per the University of Delhi notification, Reference No. Aca.I/Reservation of EWSs/2019/63 Dated 28th March 2019 and Reference No. Aca. I/Reservation of EWSs/2019/101 Dated 15th May 2019, for the reservation for Economically Weaker Sections (EWSs) Category, the University Departments / Centres / Colleges have reserved 10% seats for admission for the same for this Academic Year, 2020-21. The eligibility of such applicants will be decided on the basis of fulfilling criteria prescribed in the above notifications and subject to submission of documents, issued by the competent authority, in the format provided in Appendix V.

RESERVATION FOR CHILDREN/WIDOWS OF PERSONNEL OF THE ARMED FORCES (CW)

1. Five percent (5%) of seats are reserved for applicants under this category, course-wise in all colleges.
2. All such applicants have to upload the Educational Concession certificate in the enclosed format sample to be issued by any of the following authorities on the proper letterhead :
 - (a) Secretary, Kendriya Sainik Board, Delhi
 - (b) Secretary, Rajya Zila Sainik Board
 - (c) Officer-in-Charge, Record Office

(d) 1st Class Stipendiary Magistrate

(e) Ministry of Home Affairs (For Police Personnel in receipt of Gallantry Awards)

RESERVATION OF KASHMIRI MIGRANTS (KM) (SUPERNUMERARY SEATS)

1. All the wards (sons/daughters) of Kashmiri Migrants who wish to be considered for admission to various undergraduate courses of the University have to register online as per the schedule notified by the University.
2. Up to 5% seats are reserved course-wise in all colleges for the wards of Kashmiri Migrants.
3. All the wards of Kashmiri Migrants will have to upload a certificate of registration as Kashmiri Migrants issued by Divisional Commissioner/Relief Commissioner.
4. Admission of Wards of Kashmiri Migrants will be based on cut-offs to be announced by the Colleges. A concession of maximum 10% in the last cut-off marks fixed for unreserved category applicants shall be extended to the Kashmiri Migrants.
5. Reservation under this category is not available in courses where admission is based on entrance tests.

PRIME MINISTER'S SPECIAL SCHOLARSHIP SCHEME FOR J&K STUDENTS

The applicants selected under Prime Minister's Special Scholarship Scheme for J&K students will be admitted directly to the Colleges. Reservation under this category is not available in courses where admission is based on entrance tests.

NOMINATION OF SEATS FOR SIKKIMESE STUDENTS

Sikkimese students nominated by the Govt. of Sikkim shall be considered for admission by the University in Colleges where hostel facilities are available (AC Resolutions 51 dated 05/06/1980 and 122 dated 17/12/1990). The allocation of Sikkimese students for admission as well as for hostel accommodation in respective colleges by made by the Vice-Chancellor at his discretion. Reservation under this category is not available in courses where admission is based on entrance tests.

SEATS FOR WARD QUOTA

Admission to the wards of University and College permanent in-service employees, both teaching and non-teaching, to the various undergraduate courses, excluding professional courses and other courses where admission is made on the basis of entrance test, is made according to the following criteria :

1. Admission to wards (children) of the permanent in-service employees at the college where employees are working be given on the basis of merit among such applicants subject to ordinarily one seat for every unit of up to sixty students in a course and subject to fulfilment of course-specific eligibility conditions.
2. For admission of the wards (sons/daughters) of the permanent in-service employees of the University/other colleges (teaching /non-teaching) the total number of seats for admission will not exceed six (three for the teaching and three for the non-teaching employees) on the basis of merit among such applicants subject to a maximum of ordinarily one seat for every unit of up to sixty students in a course and subject to fulfilment of course-specific eligibility conditions.
3. The admissions on the above norms will be against seats over and above the normal strength.
4. Applicants who wish to apply for admission under ward quota must fill the online registration form. They need to choose the colleges from the list for which they wish to apply at the time of registration. The schedule and process for admission under Ward Quota will be notified on the University website.

EXTRA-CURRICULAR AND SPORTS QUOTA (SUPERNUMERARY SEATS)

It is mandatory for Colleges to provide sports facilities and encourage all students to participate in sports and extracurricular activities by introducing inter-class competitions and mass sports. Representation of at least 1% each (of total intake capacity of the college) of ECA and Sports is mandatory for all colleges, subject to a ceiling of 5% (of total intake capacity of the college) in total for ECA and Sports together.

The existing provision of not more than 5% of Sports and ECA quota (subject-wise) is continued.

The actual number of seats to be filled on ECA and sports basis is decided keeping in view the facilities available, requirements of the Colleges and other relevant factors.

Additional information regarding schedule (including preliminary and final trials) and availability of seats will be notified on the University website.

Reservation under ECA and Sports categories is not available in courses where admission is based on entrance tests.

It is mandatory for candidates selected in ECA and /or Sports Categories to submit an Undertaking on Non-Judicial Stamp Paper of Rs. 100/- at the time admission stating that the candidate will participate in and /or represent the College and University, in all events as determined by College/University, for the entire duration of the candidate's undergraduate course of study, failing which the admission to the college may be summarily cancelled.

Any candidate submitting false/fake certificates will be debarred from admission to any course in any college for three years. If a candidate seeks admission on the basis of false/fake certificates, not only will be admissions be cancelled, an FIR may also be registered.

ADMISSION GUIDELINES

Admission to all Under-Graduate Programs of UoD for the Academic Session 2022-23 will be through **Common Seat Allocation System-2022 (CSAS-2022)**, based on the eligibility requirements stated in **Under-Graduate Bulletin of Information - 2022 (UG BOI-2022)** and other rules as published by the University of Delhi on its website. Admission to all UG Programs of University of Delhi will be done through **CSAS-2022** portal on the basis of the **Common University Entrance Test- Under-Graduate 2022 (CUET (UG) – 2022)**.

The **Common Seat Allocation System 2022** of University of Delhi is divided in three Phases:

- **PHASE I: APPLYING TO UNIVERSITY OF DELHI**
- **PHASE II: FILLING THE PREFERENCES FOR PROGRAMS AND COLLEGES**
- **PHASE III: ALLOCATION-CUM-ADMISSION**

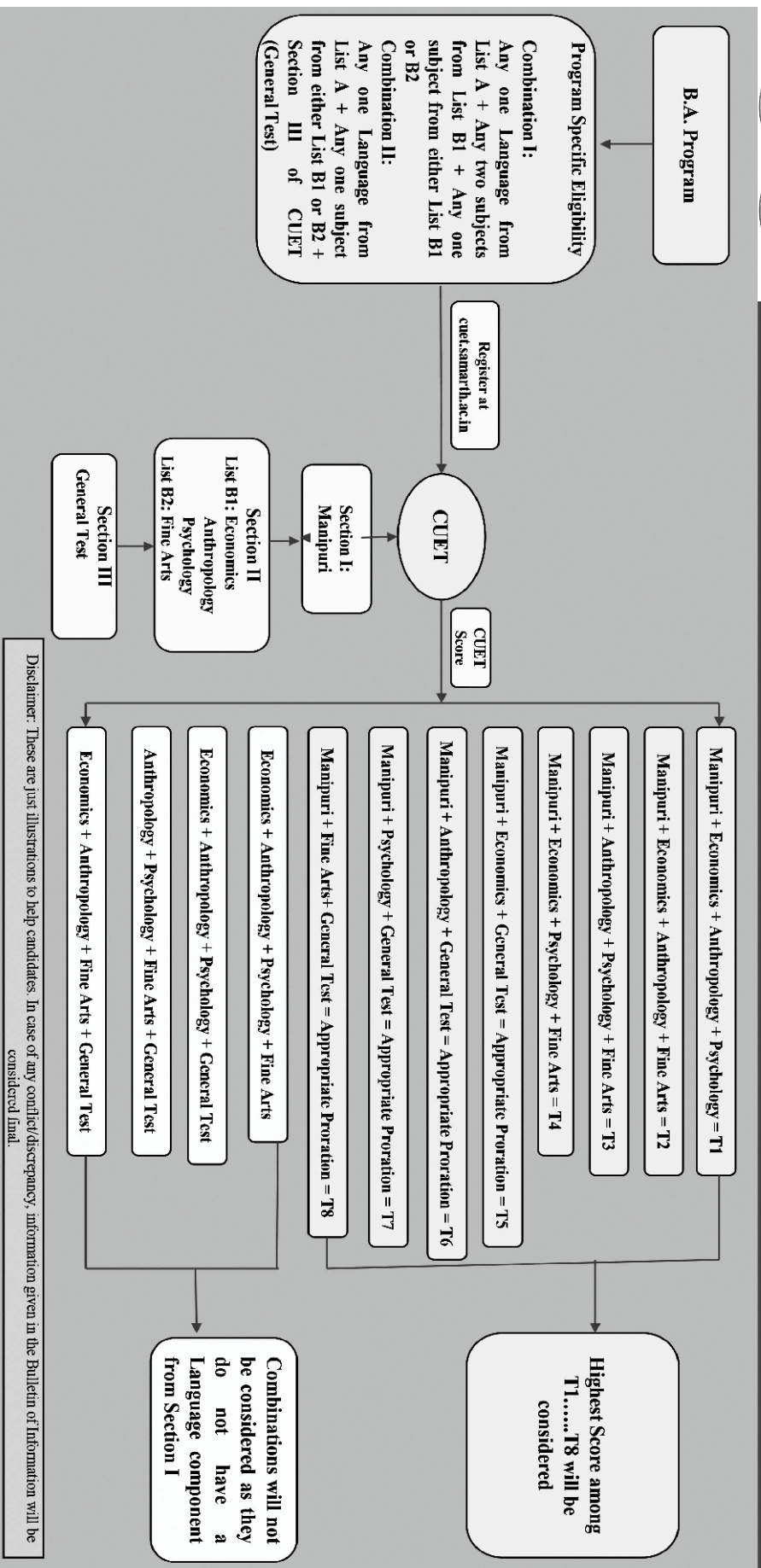

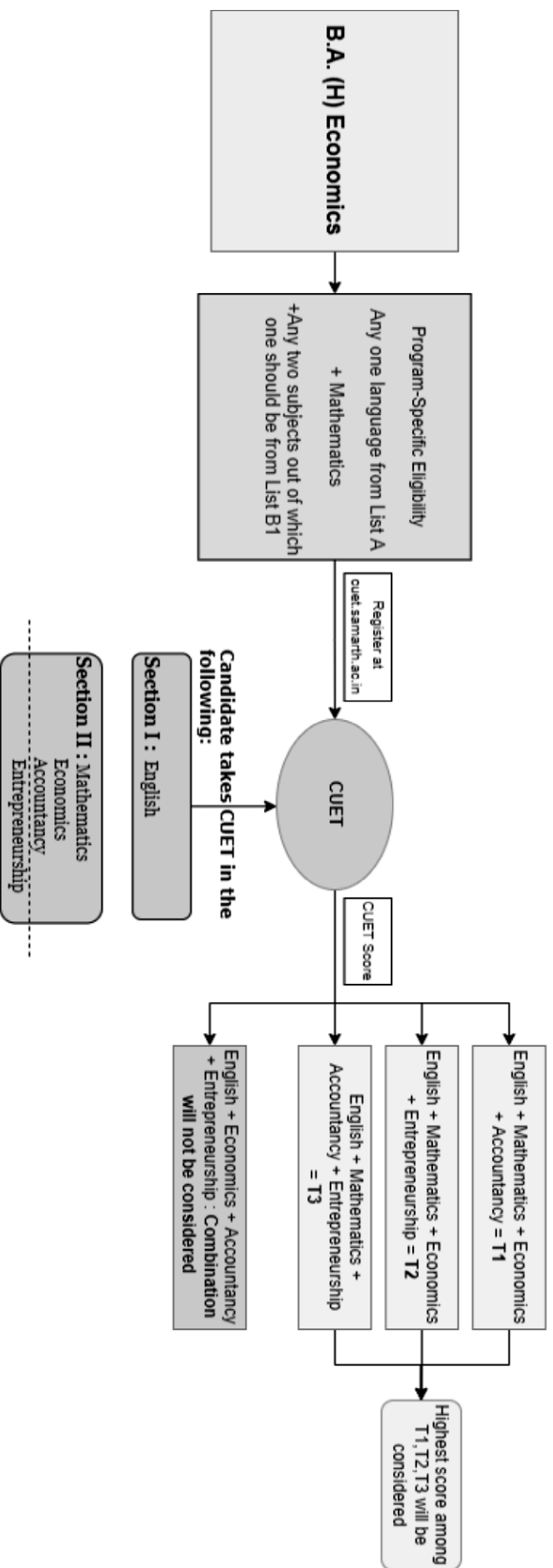

Illustrative Example for Admission to B.A. Program



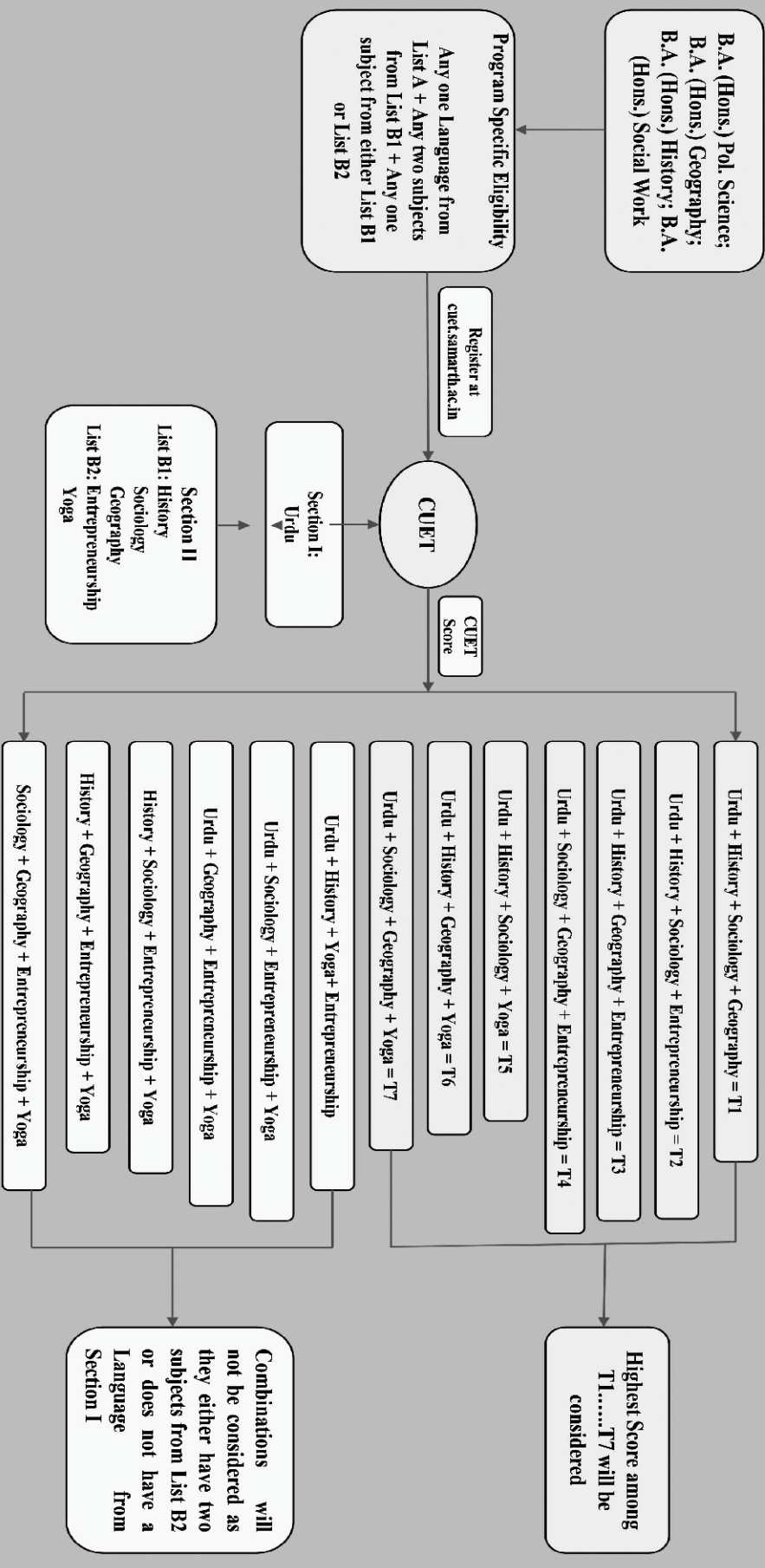
Illustrative Example for Admission to B.A. (H) Economics

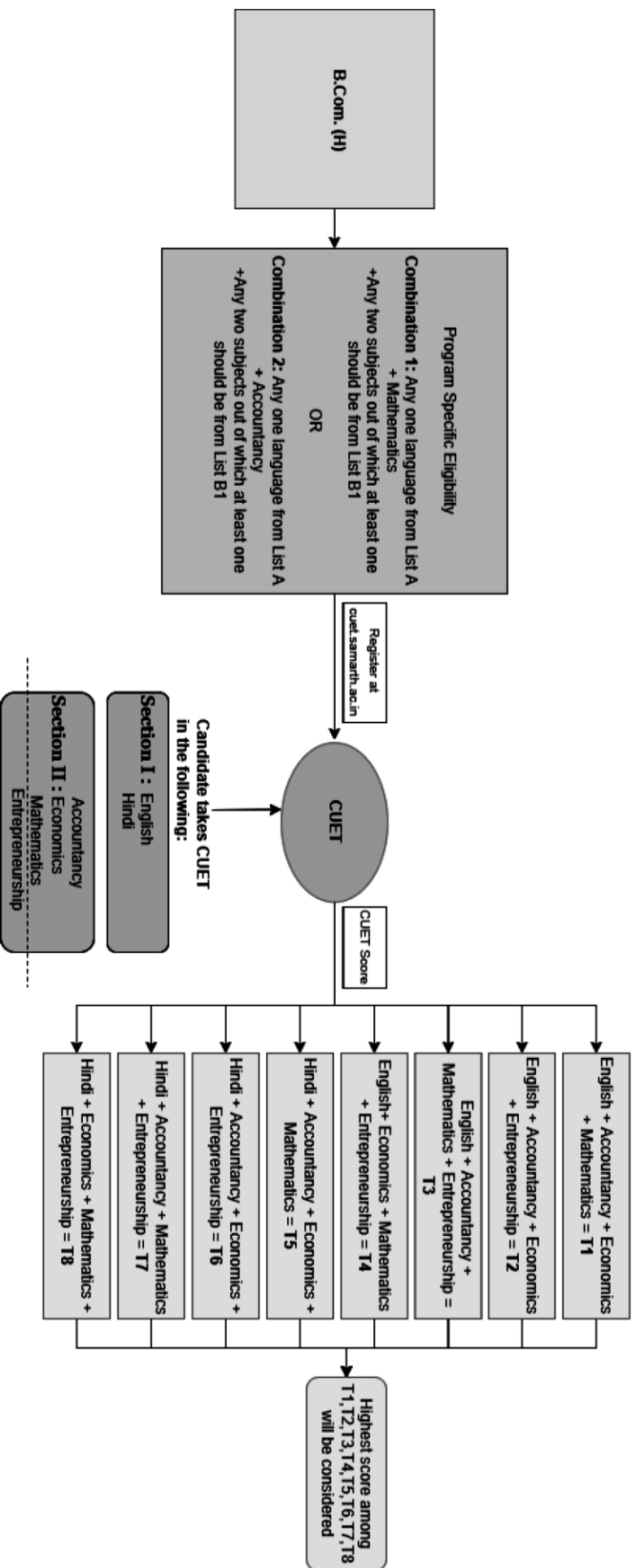

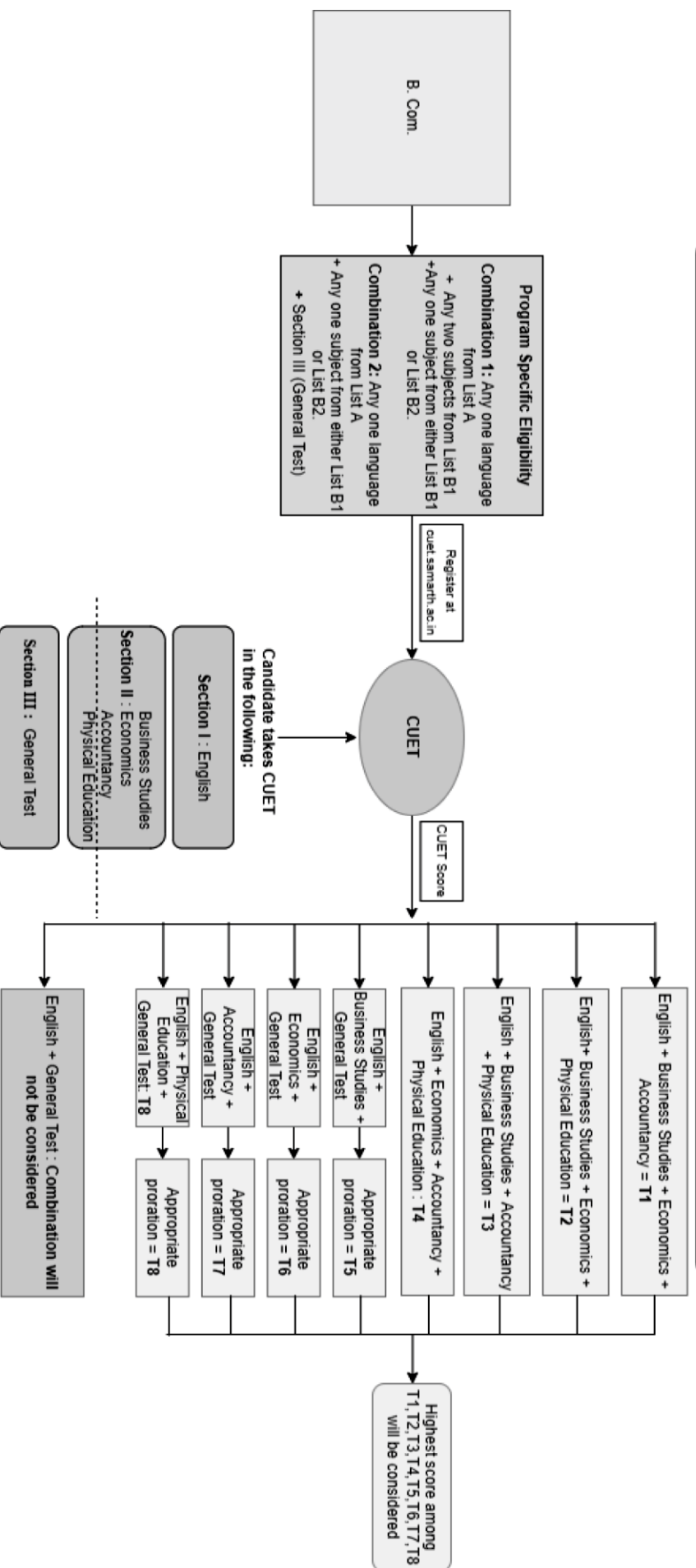

UNDERGRADUATE ADMISSIONS 2022

Frequently Asked Questions (FAQs)

GENERAL INFORMATION

1. Is there a provision for offline application form for CSAS-2022?
Candidates seeking admission to UoD must fill the CSAS-2022 Application Form online through the admission website of UoD. There will be no offline filling of the CSAS-2022 Application Form.
2. I did not appear in CUET(UG) - 2022. Can I still apply to University of Delhi for Undergraduate Programs?
A candidate who has not appeared for CUET(UG) - 2022 will not be eligible to apply for any Undergraduate Program of University of Delhi.
3. I appeared for papers/subjects which I did not study in my Class XII. Will I be considered for admission?
Candidates must have appeared in CUET(UG) - 2022 in only those subjects in which he/she has passed Class XII. These papers will be used to determine the Program-specific eligibility. (Refer to Page no 6, point no 7 of CSAS-2022).
4. Can I get a refund of the CSAS-2022 Application Fee as I no longer wish to take admission? As I could not complete Phase II of CSAS-2022, can I get a refund of my Application Fee?
CSAS-2022 Application fee will not be refunded under any circumstances.

REGISTRATION PROCESS AND UPLOADING OF DOCUMENTS

1. I have made a mistake in my category/ gender/ email id/ mobile number/ Bank Details. Can I make changes?
No changes in category/ gender/ email id/ mobile number/ Bank Details will be allowed in any circumstances once the Application Form is submitted.
2. I do not have the latest OBC-NCL certificate. Can I upload my previous year's certificate?
A candidate must have the latest OBC-NL certificate during the time of application. Previous year's certificates will not be accepted.
3. If I am not able to submit my Caste Certificate on time, will I still be considered under the UR category?
All candidates will be considered under the Unreserved Category, provided they meet the eligibility conditions and merit.
4. Do I have to fill separate forms for each Course/ Programs/ Colleges that I am interested in?
There will be only one CSAS-2022 Application Form for each candidate through which multiple Courses/ Programs/ Colleges can be applied to.
5. I do not have a Bank Account in my name. Can I use my parent/s Bank Account?
Yes. Candidate must ensure that the Bank Account details filled in by him/her are valid and belong to the candidate or his/her immediate family members. It may be noted that refunds (if any) by UoD, will be made in this account only.
6. I could not pay the CSAS-2022 Application Fee on time. Will I be eligible to participate in CSAS- 2022?
A candidate will become eligible to participate in CSAS-2022 only after the successful realization of the application fees within the stipulated time.
7. I have paid the Application Fee but due to some errors in my entries, I want to make changes. Can I be allowed to make any changes?
No change/ edit will be allowed once the CSAS-2022 Application Form is successfully submitted.
8. I have uploaded a wrong marksheet/ certificate/ document against a certain upload section. Will my CSAS-2022 Application Form get rejected?
Candidates must be careful while uploading marksheet/ certificate/ document as it may lead to summarily rejection of the CSAS-2022 Application Form.

9. I forgot to pay the fee online. Can I now pay through cheque?

No payment will be accepted through cheque. For all payments, candidates should use any of these payment modes: Net Banking / Debit Card / Credit Card / UPI.

PREFERENCE FILLING PHASE

1. I completed Phase I but missed attempting Phase II so I couldn't submit the preference for Program + College combination. Will I be considered for seat allocation?

No. The preferences (Program + College combination) must be filled within the stipulated time to be considered for Allocation Round/s.

2. I selected only 15 Program + College preferences but did not click on the submit tab. Will I be considered for allocation? If a candidate does NOT submit his/her preferences, the last saved preference order will be locked automatically (auto-locked) upon reaching the deadline of the Preference-Filling Phase. These locked preferences will become the basis for allocating seats for all rounds of CSAS-2022.

3. Will I be allocated a seat in a Program + College which I did not choose during the Preference Filling Phase?

Only the Programs + College combination selected by the candidate during the Preference- Filling phase will be considered for allocations and upgradations (if any).

4. How many preferences do I fill in the CSAS-2022 Application Form?

There is no set number. It is in the best interest of the candidates to select as many Programs as he/she wishes to join, provided he/she fulfills the Program-specific eligibility of the selected programs.

ALLOCATION-CUM-ADMISSION PHASE

1. I was allocated a seat but I could not accept it within the stipulated time. Will I be considered in the subsequent rounds?

Inactivity/no-action will be taken as non-acceptance to the Allocated Seat. It will be treated as a decline to the provisionally Allocated Seat and the candidate will no longer be able to participate in subsequent rounds of CSAS-2022.

2. I could not respond to the query raised by the College on time. Can I submit my documents physically or visit the College for resolution of the query?

During the online approval process, if a College raises a query(ies) then the candidate must respond online (through the candidate's dashboard) within the stipulated time. Failure to respond to the query(ies) will lead to rejection of the Allocated Seat and the candidate will be out of CSAS-2022.

3. I forgot to check my dashboard and could not reply to the query raised by the College on time. Can I still take admission on the allocated seat?

Failure to respond to the query(ies) will lead to rejection of the Allocated Seat and the candidate will be out of CSAS-2022.

4. Can I take admission in more than one allocated seat?

In case a candidate is offered multiple seats in a particular round, s(he) must "Accept" ONE Allocated seat ONLY.

5. I couldn't pay the admission fee on time. Can I still retain my seat/ take admission on the same seat in the next Allocation round?

If a candidate fails to pay the admission fee within the stipulated time, it will be considered as a cancellation of the provisionally Allocated Seat.

6. I selected the 'Freeze' option by mistake. Can I still opt for Upgrade'?

'Freeze' requests can be made by candidates who have taken admission on an Allocated Seat and desire to continue with it. On selecting 'Freeze', such candidates will never be allowed to opt for 'Upgradation.'

7. Will I be allocated my lower Program + College preferences during upgrade?

An admitted candidate can select the Upgrade option which will allow upgradation to a higher preference submitted by the candidate.

8. Can I re-submit a new Program + College preference list during the upgrade window?

No new addition/ deletion of Program + College preference/s will be allowed during the Upgrade window.

9. What changes can I make during the Upgrade window?

Candidates can reorder the Program- + College combinations that were higher in preference than the allocated one.

10. If I do not take admission in an Upgraded Seat, will I be allowed to retain the previous allocated seat?

Admitted candidates who opt for Upgradation will automatically be upgraded based on the allocation policy and the earlier accepted seat will be auto-canceled if new preference/s is/are allocated.

11. I have already been allocated a seat in the regular rounds. Am I eligible in Spot Admission Round?

Candidates who applied for CSAS-2022 but were not admitted to any College on the date of declaration of the Spot Admission round can only participate in Spot Admissions. Admission of already admitted candidates will be locked and not considered for upgrades.

EXTRA-CURRICULAR ACTIVITIES (ECA) 2022-23 (AS PROVIDED BY CULTURAL COUNCIL)

1. Under how many ECA categories can a candidate apply for admission under ECA quota?

A candidate can apply for a maximum of three ECA categories/sub-categories.

2. Can a candidate avail of ECA concession for the admission to a program which were the only programs that were entrance based earlier, like the BBA, BFIA, etc.?

Yes. Admission to UG Programs under ECA Category is available for all UG programs as the admission to all programs for the academic year 2022-23 is through CUET(UG)-2022 conducted by the NTA.

3. The candidate did not appear for the CUET. Is he/she still eligible for admission through ECA category?

No. For admission through ECA quota, 25% weightage is accorded to the CUET score.

4. What is the evaluation criteria for ECA and academic score?

For admissions under the ECA Supernumerary quota, the candidate's Combined ECA Merit (CEM) score will be considered. The CEM score of a candidate will be the summation of 25% of the highest Program-Specific CUET percentage score of all the Programs in which s(he) has applied and 75% of the highest score obtained from the ECA categories for which the candidate is being considered.

5. How many certificates can be uploaded under any particular ECA category?

A maximum of five best certificates can be uploaded under any ECA Category/ sub-category. The candidates are advised to read the certificate evaluation guidelines carefully and choose their best applicable ones accordingly.

6. Would a candidate be given another chance to upload certificates if needed?

Candidates would be given only ONE chance to upload certificates at the time of registration for admissions under ECA category. No requests for providing second chance would be entertained.

7. At the time of the physical trials, can a candidate bring certificates other than those that have been uploaded by him/her?

No. The candidate has to bring only those certificates for the physical trials, where applicable, as have been uploaded at the time of registration.

8. Can a candidate submit two different merit certificates of the same event and claim marks for it? The applicant can claim points for an event only once. Of the two certificates for the same event, the one getting a higher score, will be considered for the purpose of calculation.

9. Will the certificates awarded to a candidate for online activities be considered?

To take into consideration the special circumstances that prevailed during the Covid Pandemic years,

certificates for online activities, across all ECA categories and criteria, will be considered.

10. If the candidate is not satisfied with the marks awarded to him/her on the basis of certificates, does he/she have a grievance mechanism?

The marks awarded to a candidate in his/her certificates shall be shared with the candidates at the time of physical trials, where applicable. If they feel there is a discrepancy, the candidates can discuss the marks awarded then itself and ratify the final award only after being fully satisfied. Since the certificates shall be marked as per the given criteria in the presence of the candidate (except NCC and NSS categories), no grievance shall be entertained later on account of marking of the certificates.

However, for marks awarded for NCC and NSS category candidates, grievance redressal window shall be made available, after being duly notified.

11. If a candidate is not satisfied with the marks awarded to him/her in physical trials, is there a grievance mechanism for the same?

For performance in physical trials, the discretion of judges is final and binding for awarding the given score.

12. Does a candidate need to apply separately in colleges for ECA admissions?

The application and allotment process for UG Admission under ECA is done in a centralized manner by the University. So, a candidate need not separately apply to individual colleges for the same.

13. How will the process of allotment of College and programme be done for admissions under ECA Category?

The allotment of program and College to the Candidate on the basis of ECA will be done in a centralized manner by the University through a centralized ECA Merit List and based on the preferences of Colleges and programs indicated by the applicant.

For the ECA Merit list, a candidate's Combined ECA Merit (CEM) score will be considered. Additionally, the candidate must have scored at least 30 out of 75 marks in the given ECA Score to be considered for allotment under any given ECA Category/ Sub-category.

Allocations will be done on the following criteria:

(i) CEM ranking of the Candidates, subject to have scored at least 30 marks in the ECA Score.

(ii) Preferences of Program + College combinations submitted by the candidates

(iii) Availability of seats for the specific ECA category in a College.

14. Will I be consulted during allotment of the College/Programme under ECA Admission?

The Centralized ECA Admission committee shall take into consideration the College and Programme preferences of a candidate, filled in at the time of registration. The candidates are advised to give maximum preferences thereof, as individual inquiry in this matter would not be handled at any stage.

15. How important is the ECA seat matrix for admission under ECA category?

Admissions will be strictly based on the ECA seats offered by a college in a particular category/subcategory. For instance, if number of seats in NCC (Females) in a particular college is 02, then not more than 02 female candidates can be admitted under the same.

Additionally, a candidate is advised to check:

If the College is a women only college or a co-ed college. For ECA NCC category, if the NCC wing offered by the College is for male cadets/female cadets or both.

There might be some ECA categories/sub categories in which no college is offering admission for the session 2022-23.

16. Which colleges offer seats under ECA category - Divinity?

The following colleges offer seats under ECA category - Divinity

i) Sri Guru Tegh Bahadur Khalsa College

ii) Sri Guru Nanak Dev Khalsa College

iii) Mata Sundri College for Women

iv) Sri Guru Gobind Singh College of Commerce

17. If a candidate's name appears in the ECA Merit list, can he/she be assured of a seat in a college? Candidate's name appearing in the ECA Merit List does not guarantee admission in college and program. The admission of the Candidate is subject to fulfillment of program-specific eligibility criteria, the availability of program and ECA category in the College and rank in order of merit list. The final admissions are subject to the availability of seats in colleges.
18. Once admitted in a college under a given ECA category, is it mandatory for the candidate to participate in the extra-curricular activities of the College?
Yes, it is mandatory for the candidates admitted through ECA quota to represent and actively participate in the ECA category/subcategory on the basis of which they have been admitted and perform for the College and the University for the duration of their undergraduate course of study.

SPORTS SUPERNUMERARY QUOTA (AS PROVIDED BY SPORTS COUNCIL)

1. How does one apply through the Sports supernumerary quota? Is there a separate fee for applying to this quota?
You can apply for the Sports supernumerary quota by selecting appropriate options in the CSAS 2022 application form. There is an additional fee of Rs. 100 for applying under Sports supernumerary quota.
2. Is it possible to apply under Sports supernumerary quota once I have paid my registration fee? No, once you have paid the registration fee, you will not be able to apply under Sports supernumerary quota.
3. Will there be a centralized sports trial?
Yes, there will be centralized sports trial.
4. I was admitted under Sports supernumerary quota last year but could not clear the first year. Can I apply afresh and also change my programme?
You can clear your first year as an ex-student, if your internal assessment is complete (including attendance). In case you wish to apply afresh for another course, you can do so by canceling your previous admission and then filling the online CSAS 2022 application form.
5. How many Sports certificates must I upload/furnish for admission through Sports supernumerary quota?
You may upload self attested copies of a maximum of three best scoring/highest merit/participation sports certificates of each Game/Sport that you think is the best scoring. You may refer the Bulletin of Information for detailed information.
6. Which are the Sports certificates that are not considered for marking for the Sports supernumerary quota?
Sports certificate of Invitational / Memorial / Open / Prize Money League/Selection Trial / Squad/Ranking competitions will not be considered. Letter/Letterhead of Merit/Participation in Sports competitions will also be not considered. Incomplete/Cutting/Overwriting in the sports certificate will not be considered for marking under any circumstance.
7. In how many game/sport I can appear for the sports trial?
You may appear for a maximum of three games/sports for the sports trial. However, you shall be allowed to appear in the particular Game/Sport trial only in one Event/Weight Category.

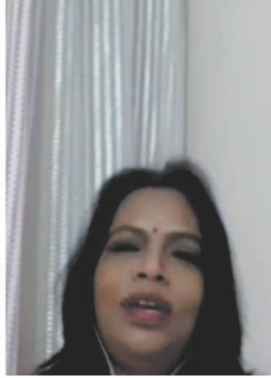





FINANCIAL ASSISTANCE & SCHOLARSHIPS AND ACADEMIC PRIZES

a) FEE CONCESSION

Financial Assistance is given to deserving and meritorious students in the form of fee concession. Students desirous of getting fee concession should apply on the prescribed form available from the College Office on the date to be notified. The consideration of fee concession depends upon good conduct and satisfactory performance of the student in the examination. Failure to show satisfactory performance, either in terms of academic results or discipline might lead to withdrawal of concession.

b) STUDENT'S AID FUND

The College has established a student's Aid Fund for the benefit of students. The object of the Fund is to render financial assistance to deserving students to meet their tuition or examination fee or to purchase books.

c) SC/ST/OBC/PWD SCHOLARSHIP

Students belonging to SC/ST/OBC etc. recognized by the Government of India are allowed scholarship by the state government. Such students are required to apply on the prescribed application form within a notified period to the respective authorities of their states through the College. Eligible SC/ST, OBS, PwD students etc. should submit their scholarship form for the academic year by February, for processing scholarship to SC/ST, OBC, PwD etc. each year.

d) RAILWAY CONCESSION

Student proceeding to join their parents at the home town from the college and back during vacations can avail rail concession. For this purpose, permanent home town address declared in admission form at the time of admission is final. It must be clearly understood that the railway concession facilities cannot be extended for visiting places of relatives or for excursion. Any changed address must be intimated directly by the parents as soon as such change takes place. Request for change of address must be supported by documentary proof/evidence.

e) ACADEMIC PRIZES

Academic Prizes are awarded by the college at the annual function to the students on the basis of their results in the annual examinations. In addition to this, following memorial cash prizes are also awarded :-

i) SHRI SUNDER LAL ROHATGI & ROOPWATI ROHATGI MEMORIAL PRIZES :

Three prizes of Rs. 250/- each to be awarded to the toppers of final year students of B.Com(H), B.Com. and B.A. Programme. These prizes were instituted by Late Sh. B.B. Rohatgi in the fond memory of his parents.

ii) KM. KANIKA GUPTA MEMORIAL PRIZES :

The prizes are of the value of Rs. 500/- given to the students securing highest marks in B.Com(H) I and II year examinations. These prizes are instituted by Dr. R.L. Gupta of the Department of Commerce, in the loving memory of his daughter, Km. Kanika Gupta.

iii) VICE CHANCELLOR'S FINANCIAL ASSISTANCE :

This Financial Assistance will be awarded to those student whose family income from all sources is less than 1 Lac per annum and having APL & BPL valid ration cards issued from competent authority.

iv) SHYAM LAL GUPTA MEMORIAL PRIZE :

A prize of Rs. 11,000/- has been instituted by Shyam Lal Charitable Trust in the memory of Late Padma Shree Shyam Lal Gupta, the Founder of the College. This prize is given to the student who secures the highest percentage of marks in the First/Second year of any course.

v) OTHER DELHI UNIVERSITY AWARDS & FINANCIAL ASSISTANCE :

There are many Awards / Financial Assistance / Scholarship scheme which are declared by the University from time to time. Students are advised to see the Notice Board for details.

vi) SPORTS PRIZES :

Sports Prizes are awarded to the outstanding sports persons every year subject to attainment of the minimum standards laid down for the purpose.

vii) STUDENTS OF THE YEAR AWARD:

Student of the year award is given to the outstanding student every year on the attainment of the minimum standards laid down for the purpose.

DISCIPLINARY JURISDICTION AND RULES OF CONDUCT

CODE OF CONDUCT FOR STUDENT

1. Students are expected to maintain a high standard of discipline and shall endeavour to promote the honour of the college and to inculcate healthy fellow feelings.
2. Student against whom disciplinary action has been taken may not be granted re-admission. Such a student will be liable to forfeit any prizes won or office held if so decided by the College Discipline Committee.
3. Student against whom disciplinary action has been taken will not be allowed to contest elections also.
4. Student shall refrain from
 - a. Misbehaviour towards members of the staff (teaching and administrative) and fellow students;
 - b. Smoking, drinking, gambling and drug-taking in any form;
 - c. Eve-teasing;
 - d. Obstructing passage in the verandah;
 - e. Causing damage to college building, furniture, fixtures, garden, canteen crockery, or to any other property;
 - f. Use of Mobile Phone in the class rooms;
 - g. Associating with outsiders to create indiscipline in any form in the college. (No outsider will be allowed in the college without any expressed purpose and all visitors will have to make entry in the Visitors Register).
 - h. Unauthorized entry in the college building on holidays;
 - i. Loitering in corridors and making noise outside and inside the class rooms.For any of the above offences students are liable to punishment which may amount to fine, suspension or even expulsion from the college.
5. Students are expected to be regular in the classes.
6. Students must keep the college neat and clean.
7. Students must maintain perfect silence in the Library and obey standing orders. They are expected to utilize the facilities properly
8. Students may participate in their favourite games or sports obeying standing rules and regulations framed by the college
9. Students must always carry the Identity Card with them.
10. Students must see the General Notice Board, the Sports Notice Board and the Library Notice Board daily for obtaining up-to-date information of College Notices
11. Students are expected not to invite any guest during the teaching hours in the college.
12. Suggestions from students are always welcome and will be given proper attention.

COLLEGE IS A SMOKE FREE ZONE !!

Any student found smoking inside the premises of the college is liable to be punished as per College Rules.

DISCIPLINE

Discipline in the college is accorded top priority. Indiscipline is punishable as per College Rules.

- The Discipline Committee is empowered to deal with cases of indiscipline
- The Principal of the College is the final authority to take action against any breach of discipline.

COMPLAINTS AGAINST SEXUAL HARASSMENT

Any kind of sexual harassment forbidden. Internal Complaint of the college resolves all complaints pertaining to this.

ANTI-RAGGING RULES

1. ZERO TOLERANCE FOR RAGGING (NOT EVEN FOR FUN) : Ragging in any form is strictly prohibited within the premises of the college and any part of the Delhi University system as well as public transport.
2. Any individual or collective act or practice of ragging constitutes gross indiscipline and shall be dealt with under the Ordinance XV-B & C.
3. Ragging for the purpose of this, ordinarily means any act, conduct or practice by which the dominant power or status of senior student is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students and includes individual or collective acts or practices which
4.
 - a. Involve physical assault or threat or use of physical force,
 - b. Violate the status, dignity and honour of students,
 - c. Violate the status, dignity and honour of students belonging to Scheduled Castes and Tribes,
 - d. Expose students to ridicule and contempt and affect their self esteem,
 - e. Entail verbal abuse and aggression, indecent gestures and obscene behavior
5. In case any student, who has obtained the degree of Delhi University, is found under this Ordinance committing an act or practice of ragging, he/she may be subjected under Statute 15 to appropriate action for the withdrawal of degree conferred by the University.
6. For the purpose of this Ordinance, abetment of ragging will also amount to ragging.

RAGGING RELATED COMPLAINTS

Any student aggrieved in this matter may fearlessly approach Convener of the Discipline Committee or any staff member of the college for speedy disciplinary action.

Anyone found guilty of ragging may be subject to any one or more of the following punishments:

- Rustication from the college
- Suspension from the college or classes for a limited period or Fine with a public apology
- Withholding scholarships and other benefits
- Debarring from representation in college events
- Withholding results
- Handing over case to the Police, if need be.

NOTE: It is mandatory as per the Hon. Supreme Court & UGC/AICTE Regulations that all students fill in an Anti Ragging Affidavit, each year. To make the process easy MHRD has developed an ONLINE Facility.

- b. All students are advised to collect their original certificates submitted at the time of admission, when instructed or at the end of the final year, failing which the college would not be responsible for them.

6. STUDENT TRAVEL CONCESSION

- a. Application forms for obtaining concession by railway are available at the general office.
- b. An application should contain the following information: –
 - i. Name of the Student
 - ii. Class in which the student is studying
 - iii. Age of the student
 - iv. Destination , i.e., town to which the student is traveling.

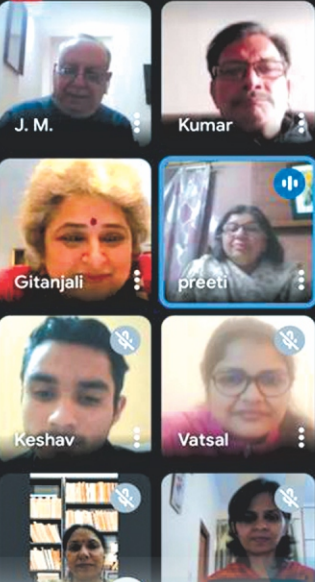
