Important Instruction to follow by the Contestant:

- 1. The prescribed nomination papers from eligible students of the College for the Office Bearers of College Students' Union and Central Councillors are to be put in the sealed box kept in the College Office from 01.09.2023 to 12.09.2023 between 2:00 p.m. to 5:00 p.m. on working days only.
- 2. All the candidates who want to fill their nomination forms for Students' Union Election 2023-24 for any post, the following documents are required with their nomination forms:
 - a) Photocopies of Identity Cards of Candidate, Seconder & Proposer, b) Mark-sheet of last examination,
 - b) Photocopy of Annual Fee Receipt (Fee paid for the Academic Year-2023-24).
- 3. An affidavit regarding not to violet the attendance criterion be submitted by the first year students who are contesting election. This affidavit is to be submitted in the Office on or before the last date of nomination.
