3. Publication of the List of duly Shortlisted Candidates after scrutiny : Tuesday, the 12th September, 2023 upto 6:00 p.m.
4. Last date for withdrawal of Nominations : Wednesday, the 13th September, 2023 upto 5:00 p.m.
5. Date of Publication of Final List of Candidates : Wednesday, the 13th September, 2023 upto 6:00 p.m.
6. Date of Election : **Friday, the 22nd September, 2023**
7. Timing of Voting : 3:00 p.m. to 7:30 p.m.
8. Counting of Votes for College Union : Friday, the 22nd September, 2023 -7:45 p.m onwards.

Important Instruction to follow by the Contestant:

1. The prescribed nomination papers from eligible students of the College for the Office Bearers of College Students' Union and Central Councillors are to be put in the sealed box kept in the College Office **from 01.09.2023 to 12.09.2023 between 2:00 p.m. to 5:00 p.m.** on working days only.
2. All the candidates who want to fill their nomination forms for Students' Union Election 2023-24 for any post, the following documents are required with their nomination forms:
 - a) Photocopies of Identity Cards of Candidate, Secunder & Proposer, b) Mark-sheet of last examination,
 - b) Photocopy of Annual Fee Receipt (Fee paid for the Academic Year-2023-24).
3. An affidavit regarding not to violate the attendance criterion be submitted by the first year students who are contesting election. This affidavit is to be submitted in the Office on or before the last date of nomination.
