

ABOUT THE COLLEGE






DEPARTMENTS





Sakshya




In the year 2021, society added two innovative ideas to achieve real goal to students' life





Computer Lab


The college computer lab is a stateof-the-art facility equipped with





RESERVATION POLICIES

Reservation of Seats for Scheduled Caste (SC) & Scheduled Tribe (ST) Applicants

- 22.5% of the total number of seats is reserved for applicants belonging to Scheduled Castes and Scheduled Tribes (15% for Scheduled Castes and 7.5% for Scheduled Tribes, interchangeable if necessary)
- It is a statutory obligation on the part of colleges to fill all seats reserved for Scheduled Castes/ Scheduled Tribes applicants.
- Colleges shall not refuse admission to any SC/ST applicant because of medium of instruction. Any deficiency in the knowledge of any language should be addressed; for this purpose, remedial classes may be arranged by the College by utilizing grants available from University Grants Commission.
- Relaxation to the extent of 5% in the minimum marks shall be given to the applicants belonging to SC and ST to determine their eligibility and merit for admission to the course concerned.
- In case, after giving 5% relaxation, the reserved seats remain vacant, further relaxation would be given to the extent required to fill all the reserved seats. (AC Resolution A88, 14.6.1983) (EC Resolution 157.24.12.2001). It is obligatory for all Colleges /Departments to fill all the seats reserved for SC/ST applicants. Eligibility in these cases is passing percentage.

The following are empowered to issue the requisite SC/ST certificate:

- (a) District Magistrate / Additional District Magistrate / Collector / Deputy Commissioner / Addl. Deputy Commissioner / Deputy Collector / 1st class Stipendiary Magistrate / City Magistrate / Sub-Divisional Magistrate / Taluka Magistrate / Executive Magistrate / Extra Assistant Commissioner.
- (b) Chief Presidency Magistrate / Addl. Chief Magistrate / Presidency Magistrate. Revenue Officer not below the rank of Tehsildar.
- $(c) \ Sub-Divisional \ Officer \ of the area \ where \ the \ Applicant \ and \ / \ or \ his \ family \ normally \ resides.$
- (d) Administrator /Secretary to the Administrator/Development Officer (Lakshadweep Islands) The applicant must note that the SC/ST Certificate from any other person/authority shall not be accepted in any case. If the applicant happens to belong to SC or ST, applicant's caste/tribe must be listed in the appropriate Govt. of India Schedule.

The Caste Certificate should clearly state: (a) Name of his/her caste/tribe (b) whether applicant belongs to SC or ST (c) District and the State or Union Territory of applicant's usual place of residence and (d) the appropriate Govt. of India Schedule under which his /her caste/tribe is approved as SC and ST.

If applicants do not have their SC or ST caste/tribe certificate at the time of registration/applying, they may upload the acknowledgment slip of the SC or ST caste/tribe certificate application. However, at the time of admission, the applicant will have to produce the valid original SC or ST caste/tribe certificate.

However, if an SC/ST applicant seeks admission under some other category (for example: PwD/Employee Ward etc.) the applicant should satisfy the minimum eligibility requirement for that category.

Note: SC/ST applicants who get admission under open merit (unreserved) shall not be included in the reserved quota, i.e. 22.5% (15% for SC and 7.5% for ST).

It is obligatory for all Colleges / Departments to fill all the seats reserved for SC/ST applicants. Minimum Eligibility in these cases is passing percentage.

Reservation of Seats for Other Backward Classes (OBC-NCL, Central List)

- 27% seats will be reserved for the applicants belonging to Other Backward Classes (OBC) (non-creamy layer, central list).
- At the time of giving admission to an OBC applicant, the College will ensure that the caste is included in the Central List of OBC (the OBC status is to be determined on the basis of the Central (Govt. of India) List of OBCs notified by the Ministry of Social Justice and Empowerment on the recommendations of the National Commission for Backward Classes available at the website http://ncbc.nic.in/backward classes/index.html.). The issuing authority for OBC Non-Creamy Layer certificates is the same as for SC/ST.
- The certificate must mention non-creamy layer status of the applicant (Non-creamy layer status issued by an authority mentioned in DOPT Office Memorandum no. 36012/22/93-Estt. (SCT) dated 15.11.1993).
- The OBC applicants who belong to the 'Non-Creamy Layer' and whose caste appears in the Central List of the OBCs only, shall be eligible to be considered for admission under the OBC category (Validity period of OBC certificate in respect of 'non-creamy layer' status of the applicants as per DOPT Office Memorandum No. 36036/2013-Estt. (Res-I) dated 31 March 2016). The validity of the non-creamy layer certificate shall be for the financial year 2025-26, issued after 31st March 2025.
- If the applicant does not have the OBC non-creamy layer certificate of the latest financial year (2025-26) at the time of registration, the applicant may upload the previously issued (older) OBC non-creamy layer certificate or the acknowledgement slip of OBC non-creamy layer certificate application. However, at the time of admission, the applicant must produce the recent financial year's (2025-26) OBC non-creamy layer certificate, issued by the same competent authority. This additional certificate must have reference of the applicant's already issued original caste certificate.
- The OBC applicants shall be given a relaxation of 10% in the minimum eligibility marks of the said course and for the admission entrance test a relaxation of 10% of the minimum eligibility marks prescribed for General / UR Category applicants.
- It is a statutory obligation on the part of colleges to fill all the seats reserved for OBC applicants.

Reservation Policy for Economically Weaker Sections (EWS)

As per the University of Delhi notification, Reference No. Aca. I/Reservation of EWSs/2019/63 Dated 28th March 2019 and Reference No. Aca. I/Reservation of EWSs/2019/101 Dated 15th May 2019, for the reservation for Economically Weaker Sections (EWSs) Category, the University Departments / Centres / Colleges have reserved 10% seats for admission for the same for this Academic Year, 2025-26. The eligibility of such

applicants will be decided on the basis of fulfilling criteria prescribed in the above notifications and subject to submission of documents, issued by the competent authority, in the format provided in Appendix V.

Reservation for Persons with Benchmark Disabilities (PwBD)

Five percent (5%) of the total sanctioned strength in each Program are reserved for PwBD candidates.

Separate Allocation result/s will be declared for candidates seeking admission under PwBD quota.

For the format of PwBD certificate, refer to Admission website: www.admission.uod.ac.in. Disability Certificates issued after 01.06.2021 must be as per the Gazette Notification no. 1736 (E) dated 05.05.2021 issued by the Department of Empowerment of Persons with Disabilities and applied through UDID portal. However, Disability Certificates issued before 01.06.2021, will be considered as per other existing applicable rules and notifications of the Department of Empowerment of Persons with Disabilities and the University of Delhi.

As per the Rights of Persons with Disabilities Act, 2016, a 'person with benchmark disability means a person with not less than forty percent (40%) of a specified disability where specified disability has not been defined in measurable terms and includes a person with disability where specified disability has been defined in measurable terms, as certified by the certifying authority'. It may be noted that the erstwhile Persons with Disabilities (Equal Opportunities, Protect of Rights and Full Participation) Act, 1995 (No. 1 of 1996), under which reservation for Persons with Disabilities in admissions was provided earlier has now been repealed.

Person with benchmark disabilities falling within any of the following specified categories of disabilities as mentioned in the Schedule to the Rights of Persons with Disabilities Act, 2016 [See Clause (zc) of Section 2 of the said Act] are eligible to get the benefit of the said reservation.

Note: For detailed information please see Bulletin of Information for Admission to UG Programs for the Academic Session 2025-26, University of Delhi.

Reservation For Children/Widows of Personnel of The Armed Forces (CW)

- Five percent (5%) of seats are reserved for applicants under this category, course-wise in all colleges.
- All such applicants must upload the Educational Concession certificate in the enclosed format sample to be issued by any of the following authorities on the proper letterhead:
- a. Secretary, Kendriya Sainik Board, Delhi
- b. Secretary, Rajya Zila Sainik Board
- c. Officer-in-Charge, Record Office
- d. 1st Class Stipendiary Magistrate
- e. Ministry of Home Affairs (For Police Personnel in receipt of Gallantry Awards)



Reservation of Kashmiri Migrants (KM) (Supernumerary Quota)

- 1. All the wards (sons/daughters) of Kashmiri Migrants who wish to be considered for admission to various undergraduate courses of the University must register online as per the schedule notified by the University.
- 2. Up to 5% seats are reserved course-wise in all colleges for the wards of Kashmiri Migrants.
- 3. All the wards of Kashmiri Migrants will have to upload a certificate of registration as Kashmiri Migrants issued by Divisional Commissioner/Relief Commissioner

Prime Minister's Special Scholarship Scheme For J&K Students

Candidates desirous of taking admission under the Prime Minister's Special Scholarship Scheme for J&K students must appear in CUET (UG) - 2025.

Nomination of Seats for Sikkimese Students (SS)

Candidates desirous of taking admission under the Sikkim nomination scheme must appear in CUET (UG) - 2025.

Sikkimese students nominated by the Govt. of Sikkim shall be considered for admission by the University in Colleges where hostel facilities are available (AC Resolutions 51 dated 05/06/1980 and 122 dated 17/12/1990). The allocation of Sikkimese students for admission as well as for hostel accommodation in respective colleges will be made by the Vice-Chancellor at his discretion.

The number of these nominated seats is detailed below:

Ward Quota of Employees of University of Delhi (WQ)


Candidates desirous of taking admission under the Ward Quota of Employees of University of Delhi must appear in CUET (UG) - 2025.

Admission to the wards of University and its College employees, both teaching and non-teaching will be done as per Academic Council resolution 9 a & b dated 27.11.2020 and subsequent amendments thereof. Candidates must be in possession of a valid Employment Certificate issued by due officials at the time of registration.

Only the Employment certificate uploaded at the time of registration will be considered. I-cards, Aadhar Card and/or any other document will not be accepted. Admissions under ward quota for each college will be determined in three Program Clusters namely viz. Humanities, Commerce and Sciences. The allocation will also depend upon the number of Programs offered in a College/Department. Allocation of Ward Quota will be based on merit scores of candidates in program clusters and the order of preferences given by the candidates. The seats under ward quota allocated for teaching and nonteaching will not be interchangeable. However, allocations may be considered within the program clusters to maximize the benefit. Appropriate proration in CUET scores may be done to ascertain cluster-based merit.

Orphans Quota (OQ)

Candidates desirous of taking admission under the supernumerary Quota for Orphans must appear in CUET (UG) 2025.



The University of Delhi will be admitting two candidates (one male and one female) in each program of study, both at the Undergraduate and Postgraduate level, these two seats will be supernumerary. The Council of the University further resolved that the expenditure incurred for admission and continuance of study of such students in the University or its Colleges shall be met from the University Welfare Fund or College Students' Welfare Fund, as the case maybe, for admission in the University or in the College.

A candidate who wishes to seek admission under the orphan's quota must possess a certificate from a Govt. recognized Orphanage/Charitable Home or Death certificate of both the parents.

As per University Notification No. Acad. I/Orphan Quota/2024-25/10 dated 16th January 2024.

Candidates seeking admission with effect from the Academic Session 2025-26 onwards under the Orphan Quota shall pay the following fees:-

- 1. Admission Fee Rs. 10.00
- 2. Examination Fee Rs. 10.00
- 3. Hostel Fee Rs. 10.00

Extra-Curricular and Sports Quota (Supernumerary Quota)

Candidates desirous of taking admission under the supernumerary quota for ECA and/or Sports must appear in CUET (UG) - 2025. For admissions to ECA and Sports supernumerary seats a weightage of 25% will be given to CUET score and 75% to certificates/trials/performances.

Single Girl Child (SGC)

01 (One) seat in each Program of every college is reserved under the Supernumerary Quota for a single girl child. The Parent/Guardian (in case parents are deceased) will have to declare that the girl child is the only Child of the parents have no other Male/Female child other than the girl child for which the application is being submitted for admissions in the academic session 2025-26. For claiming admission in this category, the father/Mother/Guardian (in case parents are deceased) shall have to upload copy of an affidavit to this effect, duly attested by the area District Magistrate/ Additional Magistrate/ Deputy Commissioner/ Collector/ Additional Deputy Commissioner/ Deputy Collector/ 1st Class Stipendiary Magistrate/ City Magistrate (not below the rank of 1st Class Stipendiary Magistrate), Sub-Divisional Magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner, at the time of online registration and should produce original affidavit at the time of physical verification of documents.

Note: Every care has been taken while describing the provisions regarding reservation in this prospectus. However, the information contained in Rules, Regulations, Ordinances and Statutes of the University regarding any type of reservation provision shall be final. The data contained in this prospectus is indicative only and must not be used for legal purposes.



Admission Guidelines

Admission to all Under-Graduate Programs of University of Delhi for the Academic Session 2025-26 will be through Common Seat Allocation System (Undergraduate) -2025 (CSAS (UG) -2025), based on the eligibility requirements stated in Under-Graduate Bulletin of Information - 2025 (UG BOI-2025) and other rules as published by the University of Delhi on its website. Admission to all UG Programs of University of Delhi will be done through CSAS (UG) - 2025 portal based on the Common University Entrance Test - Under-Graduate 2025 (CUET (UG) – 2025).

The Common Seat Allocation System (Undergraduate) 2025 of University of Delhi is divided in three Phases:

- PHASE I: APPLYING TO UNIVERSITY OF DELHI
- PHASE II: FILLING THE PREFERENCES FOR PROGRAMS AND COLLEGES
- PHASE III: ALLOCATION-CUM-ADMISSION

FINANCIAL ASSISTANCE, SCHOLARSHIPS

Fee Concession

Financial Assistance is given to deserving and meritorious students in the form of fee concession. Students desirous of getting fee concession should apply on the prescribed form, available in the college office from a notified date. The consideration of fee concession depends upon good conduct and satisfactory performance of the student in the examination. Failure to show satisfactory performance, either in terms of academic results or discipline might lead to withdrawal of concession.

Student Aid Fund

The College has established a students' Aid Fund for the benefit of students. The objective of the Fund is to render financial assistance to deserving students to meet their tuition or examination fee or to purchase books.

SC/ST/OBC/PwD Scholarship

Students belonging to SC/ST/OBC etc. recognized by the Government of India are allowed to avail scholarships provided by the state governments. Such students are required to apply on the prescribed application form within a notified period to the respective authorities of their states through the College. Eligible SC/ST, OBC, PwD students etc. should submit their scholarship form for the academic year by February, for processing scholarship to SC/ST, OBC, PwD etc. each year.

Railway Concession

Student proceeding to join their parents at the hometown from the college and back during vacations can avail railway concession. For this purpose, permanent hometown address declared in admission form at the time of admission is final. It must be clearly understood that the railway concession facilities cannot be extended for visiting places of relatives or for excursion. Any changed address must be intimated directly by the parents as soon as such change takes place. Request for change of address must be supported by documentary proof/evidence.

Vice Chancellor's Financial Assistance

This Financial Assistance will be awarded to those students whose family income from all sources is less than 1 Lac per annum and having BPL valid ration cards issued from a competent Authority.

Other Delhi University Awards & Financial Assistance:

Anti-Ragging Rules

ZERO TOLERANCE FOR RAGGING (NOT EVEN FOR FUN): Ragging in any form is strictly prohibited, within the premises of the college and any part of the Delhi University system as well as public transport. Any individual or collective act or practice of ragging constitutes gross indiscipline and shall be dealt with under the Ordinance XV-B & C. Ragging for the purpose of this, ordinarily means any act, conduct or practice by which the dominant power or status of senior student is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students and includes individual or collective acts or practices which Involve physical assault or threat or use of physical force, Violate the status, dignity and honour of students, Violate the status, dignity and honour of students belonging to Scheduled Castes and Tribes, expose students to ridicule and contempt and affect their self-esteem, Entail verbal abuse and aggression, indecent gestures and obscene behaviour. In case any student, who has obtained the degree of Delhi University, is found under this Ordinance committing an act or practice of ragging, he/she may be subjected under Statute 15 to appropriate action for the withdrawal of degree conferred by the University.

FORTHE PURPOSE OF THIS ORDINANCE, ABETMENT OF RAGGING WILL ALSO AMOUNT TO RAGGING.

Ragging Related Complaints

Any student aggrieved in this matter may fearlessly approach Convener of the Discipline Committee or any staff member of the college for speedy disciplinary action. Anyone found guilty of ragging may be subject to any one or more of the following punishments:

- Rustication from the college
- Suspension from the college or classes for a limited period or Fine with a public apology
- · Withholding scholarships and other benefits
- Debarring from representation in college events
- Withholding results
- Handing over case to the Police, if need be.
- NOTE: It is mandatory as per the Hon'ble Supreme Court & UGC/AICTE Regulations that all students fill in an Anti-Ragging Affidavit, each year. To make the process easy MHRD has developed an ONLINE Facility. Affidavits can be filled ONLINE at: www.amanmovement.org (OR) www.antiragging.in


