1. Proformas of Surety Bond on Non-Judicial Stamp Paper of Rs.100/-.
 2. Affidavit-Indemnity Bond by way of an Affidavit on Non-Judicial Stamp Paper of Rs.100/-).
 3. Affidavit DUSU Elections 2026-27 on Non-Judicial Stamp Paper of Rs.10/- are available on the University website www.du.ac.in
 4. Format of Affidavit on non-judicial stamp paper of Rs.10/- regarding not to violate the attendance criterion in the following year to be submitted by the first year students/candidate are available on the College Website www.shyamlale.du.ac.in
- You are required to submit the Surety Bond, Indemnity Bonds and affidavits on the non-judicial stamp papers as mention above in the College Office on or before submitting your Nomination Form for any post of the Students' Union Elections – 2026, failing which your nomination shall stand cancelled without any prior intimation to you.
5. Please read and understand the Code of Conduct, Constitution of DUSU, decision of Hon'ble Supreme Court of India regarding Students' Union Election "*University of Kerala v. Council, Principals, Colleges, Kerala and others*"(Lyngdoh Committee Recommendations), Hon'ble Delhi High Court orders in WPC 7824/2017 "*Prashant Manchanda v. Union of India & Ors (Defacement Case)* & WPC No. 13538/2024 "*Akhilesh Kumar Mishra & Ors. Vs University of Delhi & Ors., Delhi Metro Rail (O & M) Act 2002, Prevention of Damage to Public Property Act 1984, The Delhi University Acts & Statutes, The Delhi Prevention of Defacement of Property Act, 2007, Hon'ble National Green Tribunal Order in O.A. No. 402/2015 Nitin Chandran Vs Union of Indian & Ors., New Delhi Municipal Council Act-1994 and Municipal Corporation of Delhi Acts and the Notification DU/124/LEGAL6272(17)/2025/2377 dated 08/08/2025 issued by the Registrar, University of Delhi from University official website i.e. www.du.ac.in – DUSU Elections 2026-27.*
 6. The nomination paper should be completed in all respect. No column should be left blank. Incomplete form shall be rejected.
 7. The filled up nomination paper should be dropped in the sealed box kept in the Office of the Section Officer (Admn.) on working days between 2.00 p.m. to 6.00 p.m. but in no case later than 5:00 p.m. on Thursday, the 10th September, 2026 mentioning the Receipt Number, date and amount of Security Money in the column available on the Nomination Form.
 8. Withdrawal, if any, will be permitted if it is submitted by the candidate in person with copy of College Identity Card. No withdrawal of Nomination Form shall be allowed after 5:00 p.m. on Friday, the 11th September, 2026.
